FREE FOODIE BIN PROMOTION T & Cs

- Rules:** These T & Cs apply to applications into the **Hill's Pet Nutrition South Africa (Pty) Ltd** (the "**Promoter**") **Free Foodie Bin** ("**Promotion**"). By entering into this Promotion, you agree, on behalf of yourself and any person with whom you may share any benefit with (ie spouse, life partner) (if applicable), to be bound by these T & Cs. The types of personal information that the Promoter may collect includes information necessary for its legitimate business interests and the categories of personal information identified in relevant data protection laws in South Africa. The Promoter may use your personal information:
