(The Spot Prizes Provisional Winners and Grand Prize Provisional Winner are collectively referred to as Provisional Winners and shall as the context may require refer to an individual provisional winner who may be a Spot Prizes Provisional Winner and/or Grand Prize Provisional Winner)

The Spot Prizes Provisional Winners and Grand Prize Provisional Winner will be contacted by email after the date on which they were selected pursuant to the respective draw.
